Legacy Society Dinner Remembers & Honors Members

The Fremont Area Community Foundation held its annual Legacy Society Dinner at the Fremont Golf Club on June 16.

Past President Tom Thomsen began the evening by thanking everyone for their generosity to the Foundation. Thomsen also stressed the importance of these gifts. "The Legacy Society is vital to the future of the Foundation. Many of the gifts support the Unrestricted Endowment Fund. As this fund continues to grow, so does the number of grants the Foundation is able to give to the community," Thomsen said. Jessica Janssen, executive director of the Foundation, spoke about some of the highlights of the Foundation over the past year, including the 30th anniversary. The Foundation added a record number of 23 new funds. "2010 has been a year of celebration for the Fremont Area Community Foundation as we commemorate our 30th year. We celebrate along with the donors who had and continue to have the generosity and foresight, which allows us the privilege of impacting the community through grants, scholarships and valuable partnerships. This impact truly affects the quality of life for all citizens in the Fremont area," Janssen said.

One of those new funds established was the Jack Bryant Memorial Scholarship. The Bryant family established the scholarship fund in memory of Jack Bryant, Fremont High School educator and coach. Gordy Bryant, Jack's nephew, spoke about his uncle and the scholarship. Mike Raasch, Fremont Learning Center educator and coach, past Rotary Teacher of the Year recipient and former player for Coach Bryant, also spoke during the program.

The family of Al and Patti Bahe were honored during the evening. Mr. and Mrs. Bahe were remembered as respected educators, mentors and community members who made an impact on so many in their lifetime. They continue to do so through their family and the establishment of a scholarship in their memory. Lindsey Smrcina, recipient of the Al and Patti Bahe Memorial Scholarship and the Fremont PTA/PTSA Scholarship, also spoke during the program about her experiences as a student and future plans.

Ten new members were recognized for joining the Legacy Society. The new Legacy Society Members are: David and Kristine Gale, Dr. Greg and Mary Haskins, Robert and Dian Hillis, Russ and Jennifer Peterson and Bill and Cathy Saeger.

Foundation Awards Recent Grants

The following are grants for the community from the Fremont Area Community Foundation:

- Keep Fremont Beautiful A grant for \$860 was awarded from the Fremont Area Community Foundation for the purchase of portable recycling kits. These will help develop a project to address cigarette litter waste; improve the capture of roadway litter and improve recycling access and awareness in the Fremont community.
- Friends of Fremont Area Parks, Inc. A grant for \$10,000 was awarded from the Fremont Area Community Foundation for the start of the first phase of an allinclusive play area with technology necessary for wheel chair accessibility. Milliken Park has been selected as the place to start as they currently have numerous children with physical limitations enrolled at the school.
- **Fremont Area Art Association, Inc.** A grant for \$10,000 was awarded from the Fremont Area Community Foundation to assist with the major effort to bring the art gallery back to a condition that will allow the use of the entire building.
- John C. Fremont Days, Inc. A grant for \$5,000 from the Fremont Area Community Foundation was awarded to John C. Fremont Days toward the expansion of the programming at the Chautauqua Tent.
- Calvin Crest Camp, Conference and Retreat Center, Inc. - A grant for \$2,200 was awarded from the Fremont Area Community Foundation for the purchase of an AED (Automated External Defibrillator).

FACF Continues Endowment Challenge Grant Program

The Fremont Area Community Foundation continues to support the community beyond providing competitive grants through the development of endowment funds. "We are pleased to be able to offer endowment challenge grants to selected organizations which serve the Fremont area," said Jessica Janssen, executive director of the Foundation. "The Fremont Area Community Foundation is dedicated to helping area organizations become sustainable and build funds to support the future growth of their organizations."

The "Building for the Future" campaign is again offering matching grants of \$10,000 to five local non-profit organizations to either begin a new endowment fund with the Fremont Area Community Foundation or to grow an existing endowment fund with the Foundation. The organizations will have one year to raise new funds to receive the match of \$10,000. "We selected the Fremont Area Art Association, Fremont Area United Way, Fremont Public Schools Foundation, Friends of Keene Memorial Library and the Team Mates Mentoring Program," said Tom Thomsen, past president of the Foundation. "While it was again a challenge to select these organizations, we believe they all have a strong Board of Directors and volunteers to help them be successful in raising the matching funds."

The Fremont Area Community Foundation believes that endowment funds are key to the long-term future of an organization. Endowment funds are permanent funds held with the Foundation in perpetuity for the organization. The income generated from the funds is used to support the organization and its programs. North Bend Area Community Foundation Celebrates 10th Anniversary

The North Bend Area Community Foundation (NBACF) is celebrating its 10-year anniversary in 2010. The NBACF Board promoted the anniversary with a float during the Old Settler's parade in June. The float was not only to celebrate the anniversary but also to create awareness of the NBACF.

The organization formed 10 years ago as an affiliate fund with the Fremont Area Community Foundation. Over the years, contributions have helped grow its endowment funds. This means over \$14,000 in grants have been given back to the North Bend area. Grants have been awarded for everything from helping landscape the Morse Bluff Park to new music for the North Bend Community Band. Funds have helped with recycling efforts, youth sports, improvements at the North Bend Senior Center and contributing to bring noted children's book authors to North Bend Elementary. A recent grant helped bring Nebraska astronaut Clayton Anderson to speak at North Bend Central. The Foundation has also pledged \$10,000 to help build a new North Bend Public Library.

"Because of the generosity of many donors, the Foundation has grown stronger and is in a position to help improve North Bend into the future," Beth Vech, board member, said.
