Legacy Society Dinner Remembers & Honors Members

The Fremont Area Community Foundation held its annual Legacy Society Dinner at the Fremont Golf Club on June 17.

President Tom Thomsen began the evening by thanking everyone for their generosity to the Foundation. Thomsen also stressed the importance of these gifts. "Many of our legacy gifts support the Unrestricted Endowment Fund - the fund from which the Foundation's community grants are given," Thomsen said. Marv Welstead was also recognized for his efforts on building the Legacy Society over the years.

Thomsen spoke about some of the highlights of the Foundation over the past year. The Foundation added a record 13 new funds to the Foundation, which increased the

Foundation's assets by approximately \$330,000. One of those new funds was the Matthew Hartmann Memorial Scholarship. Doug and Kathleen Hartmann established this scholarship in honor of their son, Matthew, who was killed by a drunk driver last July. Doug spoke about establishing this scholarship.

Two scholarship recipients also spoke at the dinner: Hilary Mecham, recipient of the Rodney and Amy Mueller Johnson Memorial Scholarship and Fremont PTA/PTSA Scholarship; and Mallory Iseminger, recipient of the Matthew Hartmann Memorial Scholarship, along with Fremont Business and Professional Women's Scholarship.

John Schmitz, executive director of the Fremont Area Parks and Recreation Department, was also a speaker. The Friends of the Fremont Area Parks received a \$10,000 grant from the Lester A. Walker Fund, a component fund of the Foundation, for the Johnson Park Re-Tree Program.

Legacy Society members who passed away over the past year were remembered, including Betsy Mulliken. She was a part of the Foundation for 10 years and served as executive director from 2000-06. During her time with the Foundation, the assets more than doubled, and she was instrumental in developing the application and acceptance to the Council on Foundations to be compliant with the National Standards of Foundations. Bill Emanuel, first president of the Foundation; Mary Bigelow; Kathryn Anderson; and Leona Blazek were also remembered.

Twenty-one new members were recognized for joining the Legacy Society. Many of those were due to the efforts of Jim Ebers, who established the Rotary 5650 Program with the Fremont Rotary Club. This program is to build the Rotary Endowment Fund held at the Foundation.

Care Corps Completes Endowment Challenge Grant Program

The Fremont Area Community Foundation offered five organizations a \$10,000 challenge to encourage the development of endowment funds. The campaign is called "Building for the Future" and asked the organizations to either begin a new endowment fund with the Fremont Area Community Foundation or to grow an existing endowment fund with the Foundation. The organizations were given one year to raise new funds to receive the match of \$10,000.

Care Corps, Inc.; Crisis Center for Domestic/Sexual Abuse; Jefferson House; Friends of Fremont Area Parks, Inc.; and Fremont Opera House, Inc. were chosen to participate in this first year program which began on March 1. "We are pleased that all five organizations have accepted the challenge and are working to meet the one year deadline," said Kristine Gale, executive director. "It is impressive that in just four months into the challenge, Care Corps has successfully raised the \$10,000 to be matched by \$10,000 from the Fremont Area Community Foundation to the Care Corps Endowment Fund," said Tom Thomsen, president of the Foundation.

Care Corps immediately selected Don Hinds and Hazel Dillon to spearhead their efforts to meet the challenge. "We are proud to announce that Care Corps was able to achieve 100 percent participation from both the Care Corps Board of Directors and the Care Corps staff to help meet the overall challenge," Hinds said. Care Corps is a Homeless Shelter that provides services and programs designed to address the underlying causes of homelessness. "Endowments are for the future stability of an organization. I think 100 percent participation shows the dedication and commitment we have to serving the community and maintaining a


strong organization," Hinds said. Hinds and Dillon also went outside the organization to complete the match.

The four other organizations are continuing to work toward the match. "We know some of the other organizations are also close to making the match," Gale said. "We hope to have all of the organizations succeed in the challenge and offer this campaign to new organizations in 2010."

The Fremont Area Community Foundation believes that endowment funds are a key vehicle to ensuring the long-term future of an organization. Endowment funds are permanent funds held in perpetuity for the organization. The income generated from those funds is used to support the organization and its programs.

IRA Charitable Rollovers May Be Received Through 2009

What is an IRA charitable rollover?

The law uses the term "qualified charitable distribution" to describe an IRA charitable rollover. A qualified charitable distribution is money that individuals who are 70½ or older may direct from their traditional IRA to eligible charitable organizations. The provision has a cap of \$100,000 for charitable distributions from individual IRAs each year. Individuals may exclude the amount distributed directly to an eligible charity from their gross income.

Do donors also receive a charitable deduction when they roll over assets to a charity under this provision? No. Under this provision, donors benefit by not having to recognize the amount contributed directly from their IRA to a qualifying charity. However, because donors exclude this contribution from their gross income, they cannot take a charitable contribution deduction for the contribution.

To which charities may donors make qualified charitable distributions?

Most contributions to public charities—other than supporting organizations—are considered qualified charitable contributions. However, distributions from IRA accounts to donor-advised funds held by public charities are not considered qualified charitable distributions under this provision.

Under what circumstances will this special treatment of an IRA charitable rollover most likely benefit donors? Generally, this new provision benefits donors who itemize deductions and whose charitable contributions are reduced by the percentage of income limitation or by the itemized deduction reduction. Traditionally, when individuals receive a distribution from their IRA and make a corresponding charitable contribution, they must count the distribution as income and then receive a charitable deduction for any amounts they transferred to charity. For higher income taxpayers, the charitable contribution deduction they receive may not totally offset the taxes they must pay for receiving the distribution from their IRA. In such cases, donors would potentially benefit more by using the charitable rollover provision when making a charitable donation.

How do individuals make a qualified charitable distribution?

Individuals must instruct their IRA trustee to make the contribution directly to an eligible charitable organization.

How will charitable distributions impact the minimum required distributions from a taxpayers' IRAs?

Shortly after individuals reach the age of 70½, they are generally required to receive distributions from their traditional IRA. For the purposes of minimum required distributions, the Internal Revenue Service treats distributions from an IRA the same, whether individuals use the distribution for personal purposes or directs the distribution to a charity.
