

GRANT APPLICATION

After the March 2019 floods swept through the Greater Dodge County area, damaging homes and displacing families, community leaders came together to create the *Life's A Beach on Fremont Island* event and fund to support the Dodge County flood victims as well as the nonprofits and the first responders who spearheaded the relief effort.



Eligibility Criteria: *Life's a Beach Fund* grants are available to Fremont area individuals and families impacted by the 2019 flood, as well as the nonprofit organizations who stepped up to assist area residents impacted by the flood.

Grant expenditures: The purpose of this fund is to help with financial needs of the Fremont area residents and businesses who suffered losses or damages from the recent flood. Examples of eligible expenditures might include – but are not limited to – the following: equipment, materials and services necessary to make homes livable, and not covered by insurance, FEMA or other relief assistance; rent, hotel/motel or other short-term living expense; home repair, equipment and materials; mold abatement materials and services; replacement of essential home equipment and materials; replacement of food, clothing, and other necessities; replacement of personal materials, and miscellaneous materials, services or other expenses not listed above.

Based on current funds available, the maximum grant will be \$1,000 for households. Documentation and copies of receipts would be helpful. We ask that applicants bear in mind that these funds are provided by donors who sincerely seek to help as many Fremont area families as possible recover from flood related losses, and to assist the nonprofit organizations who stepped up to help the flood relief effort recover their above-and-beyond investment of time and resources. Please note *Life's a Beach* grants cannot duplicate FEMA assistance, insurance claims paid, or other relief assistance.

Because funds are limited, grant awards will be limited to up to \$1,000 per household.
